## ENTREPRENEUR IN DUBAI:

The exact cost to <u>become an entrepreneur in Dubai</u> and starting your business will be subject to many factors. For example, the type and scope of your UAE trade license, office space, visas needed, government approval and registration fees, and the jurisdiction you choose. Here are the typical costs for company formation in Dubai in various jurisdictions:

- 1. Mainland: **AED 17,900\*** for professional license
  - & AED 24,990\* for commercial license.
- 2. Freezone: AED 5,699\* to AED 40,000\*
- 3. Offshore: **AED 7,000\*** to **AED 24,000\***

To <u>become an entrepreneur in Dubai</u> and start a business, you will have to be careful with paperwork. Here are the documents you will typically need in the process of business setup in Dubai:

- **1.** Passport copies
- 2. Passport size photos
- 3. Business plan
- **4.** Attested MOA
- **5.** Lease contract
- **6.** Approvals from additional government bodies.
- 7. Attested service agent contract, if needed.
- 8. Financial statements
- **9.** NOC (No Objection Certificate) from local sponsor/partner if needed
- **10.** Additional documents as asked by authorities
