## Security devices and equipment license:

CERTAIN SECURITY DEVICES AND EQUIPMENT REQUIRE A LICENSE BEFORE THEY CAN BE TRADED, IMPORTED, EXPORTED, OR TRANSMITTED THROUGH THE TERRITORY OF DUBAI.

## Special license:

SOME ACTIVITIES REQUIRE A SPECIAL LICENSE EACH TIME THEY ARE CONDUCTED, SUCH AS IMPORTING OR SELLING PARAMILITARY OR POLICE DEVICES AND EQUIPMENT.
