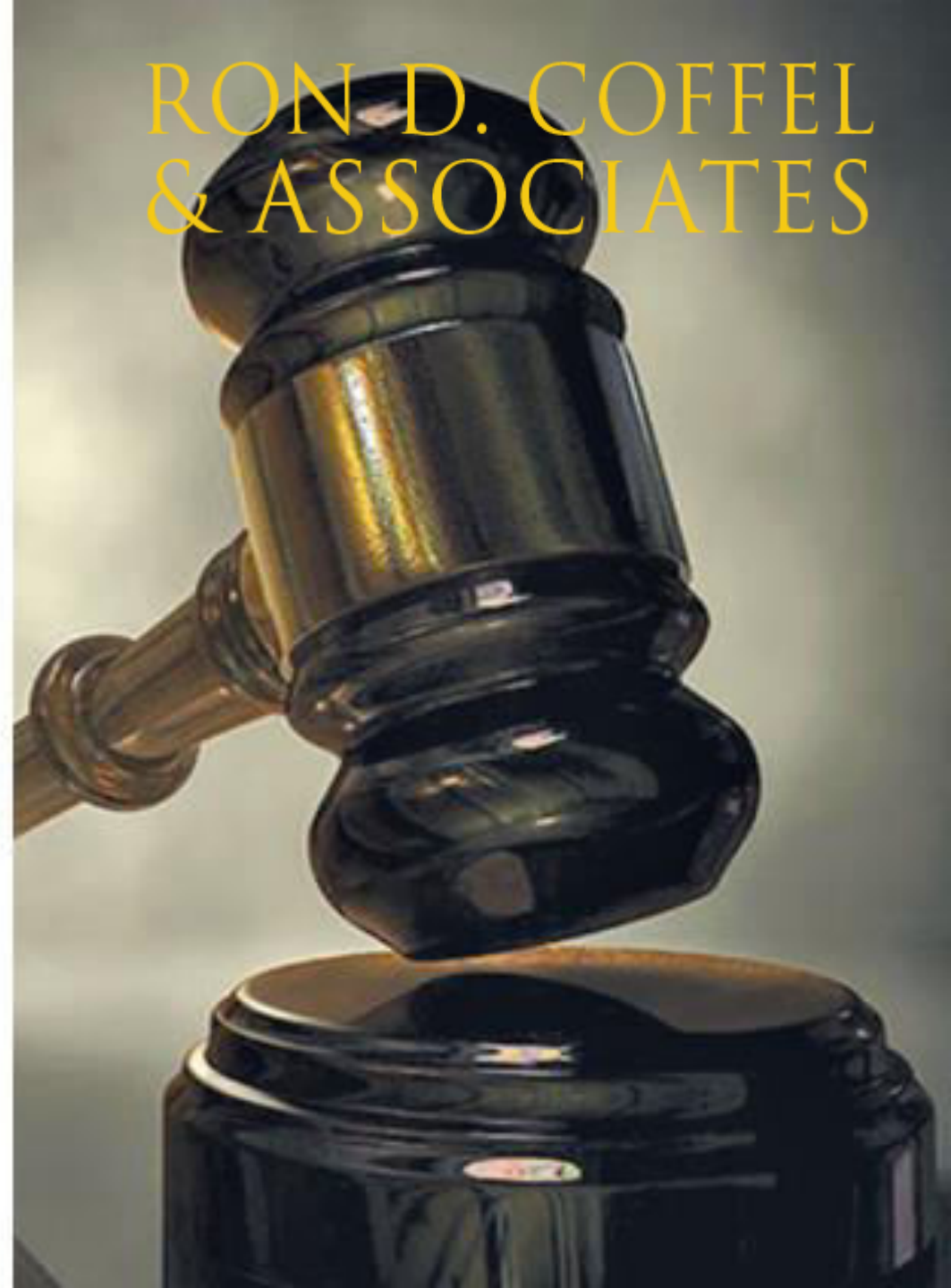


# PROVIDE LEGAL COVERAGE
