DOCUMENTS NEEDED FOR

PRIVATE CLINIC LICENSE

IN DUBAI:

Here are the documents you will generally need to start a healthcare business in Dubai:

- Physical address details of business
- Passport copies for all shareholders and managers.
- Trade certificate or proof of reserved trade name.
- Articles of Association from the UAE Embassy.
- Lease or rental agreement.
- Initial approval or certificate for the business activity.
- Resume of the manager.
- Proof of owners' finances and account balances.
- Power of attorney to appoint a business advisor.
- Notarized Memorandum of Association.

- Tradename registration fees: **AED 735***
- Memorandum of association: **AED 800***
- DHA inspection and registration fees: **AED 9,000***
